Which data is processed:

- Contact details (name, address, telephone number and email)
- IBAN and BIC (bank details for the invoicing process)
- Data relevant to your treatment

How long do I keep your data?

At your request, I must delete your data after the end of the treatment.

Inspection, correction or transfer of your data

At your request, I must provide you with access to the data that I have registered about you. I must also make corrections at your request and cooperate in the transfer of your data. If you request the transfer of your data, you can also choose to have your data transferred directly to another organization.

Cookies and Analytics

Only functional cookies are used on my website, the cookies in question are only for the purpose of a properly functioning website.

I have set Google Analytics in such a way that it cannot be traced who visits my website (IP addresses are anonymized). I can see how many people have my website visited for example. The 'data sharing' function has been disabled. I have accepted the Google Analytics Data Processing Amendment. I do not use other Google services in combination with the Analytics cookies. Finally, I selected the shortest possible period for storing the data (14 months).

How do I protect your data

It goes without saying that I will make every effort to protect your data. For example, any papers are kept under lock and key and I use passwords on my computer, which is equipped with security software. I ensure that no data traceable to your person is visible to unauthorized persons during treatment that does not concern yours.

If a situation unexpectedly arises where it is possible that your data has come into the hands of third parties, I will inform you as soon as possible. I will also report this to the Dutch Data Protection Authority if necessary.

Do you also hate unwanted telephone, email and post from sellers? I will never disclose your data to third parties without your consent, legal obligation or legitimate interest. But even then, that person or company only receives the necessary information to comply with the request.
